THE MEETING WAS CALLED TO ORDER by A. Polverento at 9:03AM.

APPROVAL OF AGENDA – B. Johnson made a motion to approve the agenda as presented. G. Boersen supported the motion. Motion carried.

APPROVAL OF MINUTES

OTHER AGENCY – Jack Knorek provided an update on MAEAP verifiers. July will be the last month that verifiers will be acting for SE Reginal Coordinators and will resume verification site visits as usual.

G. Boersen asked where MDARD was with FY26 grant agreements and if Districts need to prepare for any budget changes as we prepare our annual appropriations. J. Knorek informed the Board that we should budget as usual in anticipation that the grants will remain the same. J. Knorek informed the Board that MACD has taken a proactive approach

and given MDARD recommendations to increase pesticide license fees. This would increase funding by roughly 4 million.

A. Polverento asked why there were issues with transparency between MDARD leadership, staff, and legislature. J. Knorek was unable to answer the question directly as it is still being discussed at higher levels. J. Knorek informed the Board that MDARD is still making forward progress with Regenerative Ag and the common goal is still soil health.

STAFF REPORTS – NRCS and District Staff provided written and verbal reports.

MACD UPDATE – G. Boersen informed the board that MACD Region 7 meeting is coming up soon on August 7th. Board members should attend if available. There will be additional Director resources available starting with a Director training workshop in Jackson this fall and trainings available at the December MACD Conference in Bellaire.
